21.76 MINUTES

21.77 PUBLIC SPEAKING TIME

Two representatives of B4RN attended and updated the Parish Council on the current situation with the project in Mollington and the surrounding areas.

21.78 UPDATE REPORTS

- (1) **Speeding Vehicles**: The relevant authorities, including Cheshire West & Chester Council (CWaC), McArthur Glen and the Police were aware of the issues relating to the speeding vehicles and were keeping a watching brief. The meeting of the Cheshire Oaks Partnership had not yet taken place, but the matter would be discussed when it did.
- (2) **Bridleway, Whitby Lane**: The Clerk was asked to remind Ward Councillors Simon Eardley and Graham Heatley of the need for a meeting
- (3) It was noted that the new Notice Board for Stoak had been ordered from the Parish Notice Board Company. Delivery was anticipated in the next week or two. The Clerk had asked that Councillor Jones be contacted when delivery was expected.

21.80 HIGHWAYS, RIGHTS OF WAY AND AMENITY CLEANING

- (1) The addition of an 'S' to the Wervin sign had been reported to CWaC
- (2) The sewage on the road at Wervin had been reported to CWaC. It appeared to be coming from the Caravan Park. CWaC had confirmed that the matter had been referred to their Environment Team.
- (3) The embankment at the property on the corner of Croughton Road in Stoak was moving towards the road and was now covering the grid. The Clerk would report this to CWaC.

21.81 PLAYING FIELD AND NATURE PARK

- (1) It was proposed to combine grass cutting with a tractor/topper on the Playing Field and the Nature Park at a cost of £500 a year. It was RESOLVED that this be approved.
- (2) A new bus shelter was needed in Stoak as the current shelter was becoming dangerous. It was RESOLVED to look at alternative shelters.
- (3) When Scottish Power were doing some work on their overhead equipment they had damaged fencing. The Clerk had written to them asking for the fencing to be repaired but had not received an answer. She would attempt a follow-up.

21.82 PROTOS COMMUNITY FORUM

The Parish Council's request for funding towards the Little Stanney Village signs had been approved some two years ago. CWaC had been asked to approve the location of the signs to enable the Parish Council to order them. This had not yet been done and the Protos grant remained unclaimed. It was not clear how much longer the grant would remain available. It was RESOLVED that the Clerk should contact CWaC to ask what progress had been made so that the work could proceed and the Protos grant could be claimed.

There was still some grant money available for the current year and Members were asked to put forward ideas so that an application could be made to Protos before the money ran out. One suggestion was another two new Notice Boards, one for Wervin and one to be put outside the Village Hall.

21.84 CONSULTATIONS

National Association of Local Councils (NALC) Policy Consultation Briefing: Local Nature Recovery Strategies: DEFRA had recently launched a consultation into Local Nature Recovery Strategies and how to prepare for them. NALC would be responding to the consultation in coming weeks and was seeking the views of county associations and member councils in response to the questions within the briefing, to help inform its own submission to DEFRA.

21.85 CHESHIRE ASSOCIATION OF LOCAL COUNCILS (ChALC)

- (1) **Annual Meeting:** ChALC's Annual Meeting was to be held on the evening of Wednesday 20 October at the Canalside Conference Centre, Middlewich. The opportunity would also be available to join the meeting via Zoom.
- (2) **Board Membership Recruitment:** ChALC were seeking self-nominations to fill one of the vacancies on the ChALC Management Board. Applications to be made before 20 October.
- (3) **Planning Training Sessions with Andrea Pellegram**: Three further virtual training sessions have been arranged in November and December. The cost of each session is £30.
